RESERVATIONS:

- Limit of 2 sessions per camper.
- Rates are subject to change.
- Reservation confirmations will be sent out upon completion of registration.

DEPOSITS & PAYMENTS:

- Proper deposit amount must be included at time of online registration. Remaining balance may be paid by credit card or check and will also include the camper's store and crafts account.
- **Standard Session Fees:** Deposit (non-refundable) **\$110.00**; Membership Fee (non-refundable) **\$15.00**; Camper Fee (due May 1) **\$650.00**
Total Cost Per Session (deposit + membership + camper fee) **\$775.00**
- **C.I.T. Program Fee:** Deposit (non-refundable) **\$110.00**; Membership Fee (non-refundable) **\$15.00**; C.I.T. Fee (due May 1) **\$1,850.00**
Total Cost Per Session (deposit + membership + C.I.T. fee) **\$1,975.00**
- **TAP Adventure Fee:** Deposit (non-refundable) **\$110.00**; Membership Fee (non-refundable) **\$15.00**; TAP Adventure Camper Fee (due May 1) **\$730.00**
Total Cost Per Session (deposit + membership + TAP Adventure camper fee) **\$855.00**
- Deposits are non-refundable and non-transferable when cancelling a reservation.
- Balance must be paid in full on or before May 1.
- Scholarship applicants: A membership fee and deposit should be paid by all, and scholarship applications will be considered for any remaining amount toward the balance; subject to availability. If deposit amount is prohibitive, contact the director before October 25

CANCELLATIONS:

- DEPOSITS ARE NON-REFUNDABLE AND NON-TRANSFERABLE TO OTHER PERSONS AND/OR GROUPS.
- All cancellations must be made in writing (e-mail preferred).
- The camper fee will be refunded for cancellations that occur no later than FOUR WEEKS before the start of the session.

TRANSPORTATION:

- If you desire a pick-up or drop-off at Albany International Airport, the fee is \$150.00 per camper, per one-way trip, subject to fuel surcharge. If there is more than one camper per family, the first camper will be charged \$150 and the additional family members \$20 each. To arrange transportation, call the Tapawingo Director or the Tapawingo Business Manager.

GENERAL INFORMATION:

- No e-mail, telephone, or fax for contacting campers while in session. E-mail, telephone, and fax only for business or emergencies.
- Tapawingo is a Christian girls' camp and all rules and regulations are for the safety and welfare of campers. To be effective we need the total support and cooperation of parents and guardians.
- **Camper check-in is on Sunday at 1:00p.m and ends at 3:00pm. Tapawingo ends the following Saturday morning between 9:30 a.m. and 10:30a.m.**
Note: No pets allowed on camp grounds.
- Tapawingo registration is at the CAMP-of-the-WOODS pavilion and camper pick-up is at the Marina, located at the Point.
